



## **Tickets to Paradise – 2-to-go @ 30% Off Bird Paradise Admission**

### **Terms and Conditions**

Any bundle purchase of admission tickets to the Bird Paradise (the “**Park**”) at a discounted rate under this Promotion (“**Ticket(s)**”), as issued by Mandai Park Holdings Pte. Ltd. and its related corporations (as defined in Section 6 of the Companies Act 1967) (hereinafter referred to as the “**Mandai Wildlife Group**” or “**MWG**”), is subject to the following terms and conditions:

- Valid for same-day admission into Bird Paradise only, from **15 Nov to 17 Dec 2023** (both dates inclusive).
- 2-to-go @ 30% Off Bird Paradise Admission is valid for existing WildPass Holders and new WildPass Sign-ups only.
- Promotion is valid for 2 Adult tickets or 2 Child tickets only and not applicable for Local Senior Citizen ticket. Child is defined as a local resident aged 3 to 12 years old.
- Valid for Singaporeans, PRs, employment pass holders, dependent pass and long-term visit pass holders.

- Online payment must be made with Singapore-issued AMEX, MasterCard, or Visa cards, or NETS Direct Debit cards from DBS, OCBC, POSB or UOB.
- Admission tickets purchased as a part of this promotion are eligible for membership conversion to a Family, Individual, or Concessionary Friends of Wildlife or Friends of Wildlife Plus membership. Terms and conditions apply.
