

Terms & Conditions for Partners Portal – HSBC

HSBC 50% off Singapore Zoo, River Wonders admission tickets

From the Merchant, Wildlife Reserves Singapore, the terms and conditions shall be as follows:

- Promotion is only valid on these specified dates 13 – 15 May & 10-12 Jun 2022
- Limited to first 100 redemptions per park per month
- Limited to a total of 4 tickets per Cardmember
- Singapore Zoo and Night Safari tickets are inclusive of tram rides
- River Wonders ticket does not include Amazon River Quest boat ride; ride must be purchased separately
- Night Safari operates from Thursdays to Sundays except for public holiday or during special periods (school holidays)
- Tickets can be utilised on all days, subject to pre-booking availability, except on the eve of and during Public Holidays
- Each ticket is valid for redemption once only before stated expiry date – no extension of validity will be granted
- All other Terms & Conditions stated on the e-ticket must be adhered to

For HSBC Cardholders, the terms and conditions of the Offer shall be as follows:

- A customer who holds a HSBC credit card (except HSBC Debit cards and HSBC Corporate cards) issued by HSBC Bank (Singapore) Limited (“HSBC”, “we”, “us” or “our”) in Singapore (such HSBC credit card, a “Card”) as a credit cardholder (as the case may be), whose credit card account (as the case may be) is in good standing with HSBC over the entire Promotional Period (as defined below) and at the time of fulfilment (as determined by HSBC at its discretion) and who fulfils these terms and conditions (such customer, a “Cardholder”) shall be eligible to participate in the promotion (“Promotion”), provided that the Merchant (as hereinafter defined) shall have the sole and absolute discretion to reject any Cardholder’s participation in the Promotion.

 - (a) reject any ticket that has been re-sold in breach of this provision and accordingly deny entry to the Singapore Zoo, River Wonders, Night Safari and/or Jurong Bird Park; and/or
 - (b) invalidate all or any of the remaining tickets purchased hereunder and accordingly deny entry to the WRS Parks without prior notice or compensation to the ticket holder.
- Any admission ticket reported lost, stolen, defaced, destroyed, damaged, torn or in any way interfered with will be rejected and considered void
- Free admission for children below 3 years old
- The standard terms and conditions of admission into and tickets for the Singapore Zoo, River Wonders, Night Safari and Jurong Bird Park (collectively, the “**Standard T&Cs**”) will also apply. WildPass Application

- WildPass account applied online is valid from the date of application.
- Applicants for WildPass account are required to submit their first and last name, 6-digit Singapore postal code of their residential address, date of birth and a valid email address on www.mandai.com/wildpass.
- Applicants are required to provide consent to receiving Mandai marketing communications and agree to terms & conditions and privacy policy.
- An electronic card (“e-card”) will be emailed to the applicant’s email address upon a successful online application. No physical card will be issued for a WildPass account.
- The WildPass electronic card is personal to the registered holder(s) and is not transferable. Only the named person reflected on the electronic card may enjoy WildPass benefits.
- WRS reserves the right to reject an application, and to suspend or terminate a WildPass account without liability or refund, if any of the conditions of the account are not complied with or if any benefits are abused.
- The WildPass programme, benefits, privileges, and terms and conditions may be supplemented, amended or terminated without prior notice at the sole discretion of WRS. In the event of a dispute, the decision of WRS will be final.
