- All corporate memberships commence on the 1st day of each month and are valid for one year from date of issue.
- Each card allows 1 corporate member's staff and up to 3 accompanying guests' complimentary admission to the respective parks. The corporate member's staff must be present for admission to be valid.
- Each card can only be used once a day.
